Recently there have been a couple of instances when members of the public have drawn our attention to behaviour in the community that does not befit the high standards we set of our students at Tavistock College. These have taken place at weekends and in the evenings, and we are aware that it will only be a small minority of students who are letting us down. Whilst we are frequently left proud and inspired by what many of our students achieve and create in our local community I would like to take this opportunity to remind all students and parents/ carers of the following:

- A need to respect private property and facilities that are of use for members only. For example the Tavistock Bowls Club is a thriving community club that relies on its immaculate lawn to be able to function fully. Students are reminded that they MUST NOT walk across the bowling green as a shortcut from the BMX track into the Meadows.
- Students should be respectful of community furniture and statues when waiting for school buses. In their uniform students very visibly represent Tavistock College in these instances.
- Students should be mindful that local park facilities are sometimes designed for younger primary school students who should feel welcome at these spots.

As a College we benefit a lot from individuals, businesses and organisations in the local community. In response our students frequently go above and beyond when representing the College and really do add to the wider community that we operate in.

GDPR

As you may be aware, the Data protection law in the UK changed on 25th May 2018. The new law is called the General Data Protection Regulations.

The new regulation is about protecting people in the modern information age. It gives more control to individuals and more responsibilities to organisations that collect and hold your data.

Schools must comply too. It affects everyone: staff, parents, children and volunteers.

What will schools be doing to prepare?

We already have strict data protection policies. Data is kept secure and used appropriately. Much will stay the same but with GDPR it will bring even better security and greater transparency. In many areas consent is not needed as schools have a duty to keep children safe and deliver a high standard of education. Where consent is needed, you will be asked for it in a clear manner and be allowed to remove it, if you wish.

What data is held in school?

- Student Education Data
- · Student Medical Data
- Parent Data
- Staff Employment Data
- Staff Health Data
- Special Needs information
- Contracts with suppliers
- School Meals Data
- CCTV
- Payments information

The trustees hold all schools within the Dartmoor Multi Academy Trust accountable. As a MAT, we have a Data Protection Officer who deals with issues around staff training, audit and compliance.

Within our schools, we also have Data Champions who lead on GDPR related issues.

What do you need to do?

To help ensure that your data is secure and accurate, we are launching SIMS Parent in all schools in the Dartmoor MAT to securely collect, manage and handle key information about your child by from parents directly. Available on iOS, Android and via browser (www.sims-parent.co.uk) the SIMS Parent app provides a convenient and accessible solution for parents to electronically review and request changes to the data held on them and their children via smartphone, tablet, or PC anytime, anywhere, as well as see key term dates.

You will be able to provide additional information on crucial details such as medical information or dietary requirements, using the text information function, ensuring that personal information not previously held in SIMS is collected.

When a change request is submitted by you, automatic emails are sent to the school office. Administrators are able to view previous requests and details of any action taken via the audit trail within SIMS. From time to time, we will send notifications to remind you to update your child's details, eliminating paper based data collection and manual errors.

We will be sending you your activation link in due course. Please look out for this.

Tavistock College Uniform and Expectations

We take great care and time in any potential change to the college policies and uniform is no different. Following two terms of research, meetings and gauging the opinions of staff, parents and students we would like to confirm what the College's compulsory and optional uniform will be from September 2018. Please note, there is no significant change to the compulsory uniform.

Compulsory uniform items

- Black shoes, without logos or brands (available widely)
- Black trousers (not jeans, leggings or jeggings, skinny or slim fit i.e. not tight around the ankle)
- White shirt, worn tucked in (available widely)
- Tavistock College logo tie (available from Lawsons or from the College directly)
- Black Tavistock College logo blazer (available from Lawsons or School Trends)

Optional uniform items

- Black Tavistock College logo v-necked black long-sleeved jumper may be worn underneath the blazer as an optional item but not as an alternative to the blazer. Cardigans are not accepted. (Available from Lawsons or School Trends)
- Black Tavistock College skirt embroidered with the Tavistock College logo, either A-line or pleated. (Only available from School Trends)

 Black Tavistock College tailored shorts embroidered with the Tavistock College logo, which can only be worn from May to the end of October. (Only available from Fitness For Sport – the same supplier as all PE kit items)

Physical Education Uniform

(Available from Fitness For Sport and Lawsons and widely)

- Tavistock College polo shirt (Black with orange logo)
- Tavistock College T-shirt (Black with orange logo)
- Tavistock College shorts or skirt or capri leggings
- Tavistock College socks
- Gum shield for contact sports
- Shin pads for football and hockey

Year 11 Uniform

On the Year 11 graduation day on 5 July, there will be various celebratory events for the students who are graduating. This day will provide an opportunity for them to sign school shirts in time honoured tradition.

We are also looking for donations of old uniform, particularly ties and blazers, that can be used to support younger students.

Other expectations;

- PE/Music or other representative hoodies may only be worn for their specific activities and not instead of a blazer at any point during the College day.
- Jewellery students may wear discreet unobtrusive jewellery, for example small earrings or studs and a single ring (to be worn in the ear only).
- A plastic retainer should be worn in any other piercing. Nose and lip rings are not permitted. Health and Safety regulations for some subjects such as PE, Performance Studies, DT and Science, may require jewellery to be removed.
- Make-up, nail polish and hair natural, discreet colours only.

If for any reason an item cannot be worn for a short time, please provide a note explaining this. They will then be issued with a green slip by their Tutor. Parents will be informed if standards of uniform fall below College expectations.

We appreciate that some pupils in current Years 7-10 will have skirts or trousers that will still fit them in September and meet school uniform guidelines. For this reason, there will be a transitional period (of one academic year), so that uniform items that have been cleared by us can still be worn until new uniform needs to be purchased, up to September 2019 where the expectation is that everyone will wear the uniform listed above.

However, if uniform does not meet the guidelines outlined above, parents will be contacted and asked to ensure that new uniform is purchased that does meet these guidelines as soon as possible. This includes short skirts and skirts made of stretchy material.

Thank you for your continued support in helping us maintain high standards and ensure all pupils are comfortable, but also smart and presentable in College.
